On June 6, 2006 the Company issued its previously declared stock dividend of one share of Class A Common Stock on each share of Class A Common Stock and each share of Class B Common Stock issued and outstanding on the record date of May 22, 2006. As a result of the stock dividend, Mr. Yeager received 179,564 shares of Class A Common Stock. 14,134 of the shares of Class A Common Stock are restricted stock subject to vesting requirements.

2. Mrs. Yeager received 1,000 shares of Class A Common Stock as a result of the stock dividend issued on June 6, 2006.

3. The Yeager family members are parties to a stockholders' agreement pursuant to which they have agreed to vote all of their shares of Class B Common Stock in accordance with the vote of the holders of a majority of such shares. Members of the Yeager family own all 662,296 shares of the Class B Common Stock.
